Dear Council President Clarke:

This letter is in response to questions raised at the April 2<sup>nd</sup>, 2014 hearing before the Committee of the Whole on the Fiscal Year 2015 budget for the Commerce Department. The questions were recorded as follows:

#### From Council President Clarke:

1. Can you provide a list of the selection committee members for the corridor cleaning grant selection?

The selection committee includes representatives for the Department of Commerce Office of Business Services, Keep Philadelphia Beautiful, Department of Commerce Office of Neighborhood Economic Development, Department of Commerce Office of Neighborhood Economic Development, Department of Commerce Office of Neighborhood Economic Development, Philadelphia City Planning Commission, and the Streets Department.

2. In your testimony you mentioned, \$7.5 billion in construction will be occurring in Philadelphia, can you explain Commerce's role in this and where this particular development took place, the time frame for this construction, and the geographical location?

Attached is a spreadsheet (Exhibit A) highlighting many of the construction projects completed since January 2013, currently under construction, or in advanced stages of planning. The projects in the spreadsheet represent \$7.35 billion in project cost but there are many projects currently underway for which we do not have final project cost numbers, therefore \$7.35 billion is a conservative estimate. There are also future projects which are in the pipeline but not yet public which represent additional investment in Philadelphia.

The Commerce Department works very closely with real estate developers and investors in a number of ways to help bring projects to fruition. The Developer Services Unit within the Commerce Department guides developers through the approval process and brings together all relevant city departments to ensure a coordinated approach from city government. I personally meet with many developers to provide advice and guidance on a range of issues including design, zoning, community engagement, and financing. We also work with developers to help recruit retail tenants for commercial spaces.

#### From Councilwoman Brown:

#### 4. Can you provide to the Chair information on the new Manufacturing Task Force?

Mayor Nutter announced the creation of a Mayor's Manufacturing Task Force in January 2013 to evaluate the City's competitiveness for manufacturing and recommend specific strategies for growth. The Task Force was co-chaired by Deputy Mayor Alan Greenberger; Dan Fitzpatrick from Citizens Bank; Bill Hunt from AgustaWestland; and Councilman Bobby Henon. The Commerce Department is coordinating – in close partnership with Councilman Henon – the implementation of many of the recommendations of the Task Force. For example in March 2014 I announced that announced that Michael Cooper, previously a Vice President of Marketing and Business Development at the Philadelphia Industrial Development Corporation (PIDC), will serve as the Director of the newly-created Office of Manufacturing and Industry within the Department of Commerce, the creation of which was a recommendation of the Task Force.

# 5. Can you provide to the Chair where the businesses that have taken advantage of the Commerce SafeCam program are located geographically?

#### From Councilman Henon:

7. Can you provide to the Chair the current vacancy rate for commercial corridors and that of past years?

Using Planning Commission PhilaShops survey data, an average vacancy rate for commercial areas (of all types & sizes) is currently 17.7%, a .3% increase from the 2003 survey.

The average vacancy rate in the commercial corridors that have active commercial corridor managers in place (and are neighborhood pedestrian/transit oriented by type) is currently 18.5%, but that is down 5% from 23.7% in 2003.

#### From Councilman Oh:

8. Can you provide an updated department demographics table for the Commerce department?

9. Can you provide information to the Chair on how much the Mayor's 6 (Brazil, China, United Kingdom, Israel, South Africa and Rome) international trips cost?

The Commerce Department was responsible for organizing the Mayor's trade mission to the United Kingdom and Israel and the Mayor's visit to China.

China – \$11,026.81 UK/Israel - \$29,806.26

Costs for these visits were minimized through the extensive use of in-kind contributions, Sister City relationships, and hotel reward points for example. Also attached is a report of outcomes to date from the trade mission to the UK and Israel (Exhibit F).

The Mayor's Office will provide details on the travel to Brazil, Rome and South Africa upon request.

## **Commerce SafeCam Program Guidelines**

City of Philadelphia, Department of Commerce

#### **Program Description**

The purpose of the Commerce SafeCam Program is to encourage businesses and property owners within the City of Philadelphia to install surveillance cameras, making areas safer for shoppers and the community while growing their vitality and economic performance. The program reimburses owners of commercial buildings and businesses up to 50% of the total cost of eligible improvements, for a maximum reimbursement of \$3,000 for a single commercial property. The digital camera security system must be installed on the outside of your building providing surveillance for your business and the public space.

#### **Eligible Applicants**

Applicants must be the owner of a commercially occupied property or an operating tenant business with approval of the property owners or an established business association or community based organization representing a number of businesses in a particular area. Applicants must be operating legally, properly registered, licensed with the City of Philadelphia and current with all City obligations, including but not limited to taxes, licenses, water revenue billings, as well as any assessments due to Business/Neighborhood Improvement Districts. Unoccupied properties may be considered but must be occupied or have a signed lease agreement to be eligible for reimbursement.

#### **Eligible Equipment**

All surveillance system equipment shall be subject to review and approval by the Philadelphia Police Department and requirements may vary by business type and property. The following are the minimum specifications required for a Commerce Safecam Program award.

#### **CAMERAS**

- 1. IP-enabled.
- 2. Operate with a minimum of 480 Total Vertical Lines (TVL) of resolution.
- 3. Capable of recording color images during sufficient lighting and recording black and white images during hours of low light.
- 4. Tailored to each Eligible Property taking into consideration:
  - the distance to the target image;
  - the "lux rating" or compatibility with the amount of light available to include excessive amounts of sunlight; and
  - the view angle of camera in relation to area of desired coverage.
- 5. Have a clear and unobstructed view of outside areas of desired coverage.

#### DIGITAL VIDEO RECORDINGS (DVR) or NETWORK VIDEO RECORDINGS (NVR)

- 1. DVRs must have one dedicated channel for each camera in operation.
- 2. Record at least 640 X 480 recording resolution levels.
- 3. Have the capacity to record at least fifteen (15) frames per second, per camera.
- 4. Have sufficient memory to retain data from all cameras for a period of at least fifteen (15) days. Possess the ability to view and retrieve data while the system remains in operation.
- 5. Possess the ability to produce a copy of desired data for evidentiary purposes.
- 6. Be placed in a locked and secured location to prevent destruction or tampering.

#### **Application Process**

- 1. Contact Philadelphia Department of Commerce at 215-683-2172 to request an application. The application will require:
  - a. Photos of your building clearly showing where surveillance camera will be located, and at least one photo showing the entire front façade of your building.
  - b. Estimates from two (2) licensed contractors detailing camera specifications.
  - c. A letter from building owner (if this is not you) granting permission for the proposed work.
- 2. Completed applications should be delivered to Linda Lawrence, Dept. of Commerce, 1515 Arch Street, 12<sup>th</sup> floor, Phila, PA 19102 or <u>Linda.Lawrence@phila.gov</u>. The applicant will be notified that the application has been received and whether anything is missing. Incomplete applications will not be considered.
- 3. Philadelphia Department of Commerce will send an award letter, specifying amount of reimbursement.

  Once received, the applicant can proceed with application for electrical permit, purchase and installation.
- 4. Once the cameras are installed they must be registered with the Philadelphia Police Department SafeCam crime prevention and investigating tool. https://safecam.phillypolice.com/registration
- 5. When registration is complete, submit copies of invoices, proof of payment, copy of a passing final electrical inspection certification, color photos of the installed cameras, and a copy of SafeCam registration to the Dept. of Commerce and a reimbursement check will be mailed out.

#### **Additional Program Requirements**

- Economic Opportunity: As part of Mayor Nutter's Strategic Plan for this Administration, a goal to create and retain jobs by fostering an improved business environment has been established. One of the strategies designed to achieve this end is strengthening supports to minority, women, and disabled residents and businesses. All applicants certify to make "best and good faith efforts" to include businesses owned and controlled by minority persons (MBEs), women (WBEs) and disabled persons (DSBEs) in their projects. In excercise of "best and good faith efforts" applicants for this program must solicit MBEs, WBEs and DSBEs for participation in the project. - The amount that this program is able to approve for reimbursement will not always be equal to 50% of the eligible costs or the maximum amount due to availability of funds and restrictions in how program funds can be spent.
- Projects within areas with special design controls or within historic districts must comply with those requirements.

### Frequently Asked Questions

- 1. If a restaurant needs to install 2 outdoor cameras and 6 indoor cameras, how do you calculate the reimbursement regarding the shared DVR fee and installation fee?
  - Applicants must get itemized estimates. Commerce Department will calculate project cost by adding the cost of exterior cameras, installation, DVR unit and any other necessary components for exterior camera system, and reimburse at 50% up to \$3,000. The entire system required for the exterior cameras will be eligible.
- 2. As stated in the Guidelines, what do you mean by "estimate from 2 licensed contractors"? Does it mean the "licensed installer", "licensed company", or both of them?
  - Applicants must get multiple estimates (at least two) for each component charged to the project. Estimates must be from businesses licensed to work in Philadelphia.
- 3. Both Storefront Improvement Program and Commerce Safecam Program can help businesses with the cost of installing exterior security equipment. Which program shall we choose? What is the difference?
  - Commerce SafeCam Program is available to any business operating anywhere in Philadelphia. Businesses should use the Commerce SafeCam Program if the business/property owner is only interested in acquiring a security/surveillance camera for the exterior of the business. The max award is \$3,000.
  - Storefront Improvement Program is able to reimburse the cost of cameras if that improvement is taking place along with façade improvements AND the business provides goods and services on a targeted commercial corridor. The max award (for façade upgrade and cameras) is \$8,000 (single storefront) or \$12,000 (corner or mult-storefront).
- 4. There is a narrow alley behind my business. Residents dump there and homeless people get together there at night. Would the program help us to install camera to monitor my back door?
  - Yes, the rear alley is public space.
- 5. I have a rental property zoned as residential. Is my property eligible for the program?
  - Sorry, at this time the Commerce SafeCam Program is for businesses only.
- 6. Between the two estimates, shall we choose one contractor ourselves? If so, are we required/supposed to select the one with lower prices?
  - Yes, the applicant selects the contractor(s). If the applicant does not select the contractor with the lower price, the reason for that choice must be explained in the submitted application.
- 7. Can I install the camera myself?
  - No, surveillance cameras must be installed by a licensed contractor who is licensed to do work in Philadelphia and obtain necessary permits.
- 8. What shall I do if the cameras are stolen after installation?
  - Contact your insurance company and the Police to file a report.

9. How can I get the static IP to connect to Police Department?

The Police Department is in the process of connecting to personal surveillance systems in Philadelphia. In the meantime, it is required that cameras funded through this program be registered with the Police SafeCam program.

10. Does this program reimburse the guaranty and insurance of the cameras?

Yes, if they are included in the estimate and are to be paid upfront to the contractor who has been chosen by the applicant to install the surveillance camera system.

11. What is the general process time to get the approval?

There is an approximate 2-4 week process time for approval. Applicants should not begin work until they have received an approval letter from the City.

After the project is completed and the awardee submits documentation for reimbursement, payment will be mailed out in 2-3 weeks.

12. Who has the liability of the cameras?

The applicant who paid for the cameras.

13. I cannot speak English and there is only one licensed installer speaking my language in my community. What shall I do to get another estimate?

It is in your interest and the City's to get multiple estimates and make sure you are getting the best price. If there is a compelling reason why the applicant has secured an estimate from only one contractor that should be explained with the submitted application.

14. Do I have to buy an IP camera?

The camera must be IP-enabled camera, but does not have to be an IP camera. IP enabled is a much broader category which should not limit the choices that are commercially available. Analog cameras that meet the other specifications can be approved for this program.

15. Do I have to get the estimates from minority business? Do you have a list?

The Department of Commerce requests that all applicants make a good faith effort to acquire estimates from minority, women, and disabled owned businesses.

Below is a list of Philadelphia based companies that do surveillance camera installations and are Office of Economic Opportunity (OEO) registered minority or female owned contractors.

#### **Outcomes from Israel & UK Trade Mission**

#### 1. Philadelphia business delegates who participated in the mission

UK: 13 businesses & Israel: 12 businesses

Introductions made during the mission were thoroughly vetted (by PA and partners), on target, and generated numerous leads for every delegate. The outcomes range from consulting agreement, partnership opportunity, bidding for the next contract, and getting international designation/recognition, to setting up an UK office satellite office and many delegates are planning to go back to the UK and Israel to pursue these outcomes.

- Environmental Construction Services (Energy saving HVAC construction services and parts)
  - o In the process of bringing their services & products to Europe for commercialization and establishing a UK office to represent US products.
  - Grew from 4 to 38 employees between Sept and April. Attributes 3 recent hires as a direct result of the trade mission.
  - Currently in Northeast Philly, they have outgrown their space and ready to expand to an office and manufacturing plant this fall. Commerce is assisting.
  - CEO Michael Brown is a graduate of the Goldman Sachs 10KSB
- Azavea (GIS software developer)
  - Signed an agreement with the UK-based Open Data Institute (ODI) to become the Philadelphia regional ODI node
  - Hosted representatives from London Metro Police Service in February, who visited
     Philadelphia to learn about <u>HunchLab</u>, our predictive policing software product
  - Participated in a UKTI event on Smart Cities in NYC, showcasing their products OpenTreeMap and HunchLab
- Derbyshire Machines (Ship part manufacturer)
  - Pursuing UK shipyard contract in US & UK joint shipbuilding programs on carriers and submarines with a UK engineering consulting firm
  - o VP from Babcock International (owner of shipyard in UK) visited Derbyshire in April
  - o Planning to open a UK office
- Message Agency (Software developer)
  - Consulting and partnership agreement in progress
  - o CEO Marcus Iannozzi is graduate of the Goldman Sachs 10KSB
- Knowledge @Wharton (Online business analysis journal of Wharton at Penn)
  - Planning underway to hold Wharton Global Forum in Tel Aviv in 2015

#### 2. UK & Israel businesses

In less than 5 months after the trip, 4 companies from the UK and Israel have visited Philadelphia to establish their US headquarter/operation in the city.

 ClearVision (UK): Systems software developer. During their visit in April, they decided to graduate from a virtual desk presence to locating their US operation here and hiring. Read their blog entry on why they chose Philadelphia.

Next 3 are in progress -

- Healthy Weight Partnership (UK): Anti-child obesity training program. In business in the US since 2007 and wants to make Philadelphia their US headquarter.
- Carbon Conversion Technology (UK): Build a tire conversion-to-energy plant. Estimated 75 jobs

• Covertix (Israel): document security software developer. Wants to base their US operations here.

#### 3. Increased exchange between Philadelphia and UK & Israel via visits and hosting major events

- UK delegation participated in GreenBuild convention in November 2013
- Manchester, UK delegation in March 2014
- UKTI plans to organize a delegation to Manchester & Liverpool to coincide with a 8-week long International Business Festival the UK in the summer.
- British Research Establishment paid a repeat visit to advance establishing an Innovation Park
- Planning under way for Israel-Philly forum in October. Israel delegation led by Pitango VC (Chemi Peres) and Israeli Advanced Technology Industries
