Dear Council President Clarke:

This letter is in response to questions raised at the April 7th, 2015 hearing before the Committee of the Whole on the Fiscal Year 2016 proposed budget for the Mural Arts Program. The questions were recorded as follows:

From Councilwoman Sanchez:

1. Can you provide us a snapshot of your fundraising efforts?

In FY14 (our most recently audited fiscal year) Mural Arts raised \$3,866,676 from foundation and corporate sources and \$691,499 from individuals. Additional revenue included \$4,731,673 in government contracts and \$317,935 in other contracts. These numbers represent increases from FY13, when we raised \$3,141,467 from foundation and corporate sources and \$670,922 from individuals. Additional revenue in FY14 included \$3,728,180 in government contracts and \$308,767 in other contracts. In FY15, we predict having raised nearly \$5,000,000 from foundation and corporate sources and nearly \$800,000 from individuals. Several of the foundation revenue sources provided multi-year gifts, including a single \$1,250,000 three-year grant from the Kresge Foundation.

This year (FY15), Mural Arts' fundraising expenses, including salaries, is \$567,524. This covers the cost of four full time staff members. Fundraising efforts are focused on 1) raising unrestricted revenue to cover operating costs and improve the organization's capitalization; 2) matching public investments in our programs targeting underserved and vulnerable populations; and 3) investing in Research & Development and innovative large scale projects.

In FY15 to date, we are seeing the following ratios between public and private funding within our programs:

Porch Light Program

Restorative Justice Program

- Local Public Investment: \$360,000 (Prison System and City of Philadelphia appropriation)
- Raised Revenue: \$419,329
- Private funders: JP Morgan Chase, Bryan Weingarten, Frank & Ann Reed, Connelly Foundation, Ford Foundation, Hummingbird Foundation, Fierce Advocacy Fund

Mural Arts is increasingly attracting revenue from competitive national funders, including the Ford Foundation, Kresge Foundation, John S. and James L. Knight Foundation, the National Endowment for the Arts, Fondation D'Entreprise Hermès, Elizabeth Firestone Graham Foundation, Robert Wood Johnson Foundation, and the Surdna Foundation.

In FY15, revenue booked from national sources amounts to \$2,375,000.
