### Where to Go:

Contact the County Veterans' Affairs Director in the county you reside to set up an appointment. See list included with this checklist.

### The Following Documents are Needed:

- [Obtain](#) your Certificate of Release or Discharge from Active Duty, also known as your DD214.
- Have your DD214 recorded in the County Recorder's Office to safeguard your records. You will need them again. Visit [www.phila.gov/records](http://www.phila.gov/records) online, or call 215-686-2261 for more information.
- Make a free appointment with the Veterans Advisory Commission or Accredited Service Organization to receive advice the services you may qualify to receive. Be sure to bring:
  - Service Medical Records
  - Personnel File
  - Dental Record

Register for VA Healthcare benefits [online](#) or by using the [10-10EZ form](#).

### Housing and Real Estate

When you are ready to buy a home, be sure to tell your lender that you are a veteran and are interested in using the [VA Home Loan Guaranty](#). You will be asked to provide a copy of your DD214.

### Employment

If you need employment assistance, call or visit your local Philadelphia CareerLink office to speak with a Veterans Employment Representative about the following:

- An assessment of your military skills that can be valuable in civilian employment.
- Vocational training and other classes that can enhance your skillset.
- Assistance in connecting with employers seeking veterans.

### Education

Review the latest updates to the [G.I. Bill](#) and [Yellow Ribbon Funding](#). When visiting colleges, always identify yourself as a veteran and ask to speak to the college's Veterans Representative. The Commonwealth of Pennsylvania always makes an Educational Gratuity available to disabled veterans and their children.
