Dear Council President Clarke,

This letter is in response to questions raised by Councilmember Gilmore-Richardson during the FY22 Council Budget process via writing. The Councilmember requested a series of data and narratives related to contracting with M/W/DBE firms. In FY22, the Administration proposes spending \$929 million on services, materials, and equipment (Classes 200, 300 and 400), excluding the Sinking Fund's debt repayments, utility bills, the SEPTA subsidy, and the Convention Center subsidy. Currently, we are able to provide the following contracting data for all departments from FY16 through FY21Q3 including:

- Vendor Name
- Department
- Contract Amount
- Philadelphia address (Yes/No)
- Pennsylvania address (Yes/No)
- For Profit Code (Yes/No)
- OEO Selection (Woman, Minority, or N/A)
- Contract Type (Single Prime, Unitary)
- Participation Amount

The remaining requests will require additional research not feasible to conduct within the budget process Q&A timeline. Much of the data is not stored in a system enabled for reporting in this manner and will require manual effort by City staff and consultants (which will require either additional funding or forgoing planned work). Given the level of effort required for this analysis and availability of information, the Administration projects that not all items can be provided. Please understand that while we may be able to pull a report showing if an award was made to a registered Minority- or Women-owned but we would not have gender, or specific race and ethnicity data as that is not captured in the contracting process, although some anecdotal info may be available in some instances.



To provide the most robust response possible with a reasonable expenditure of City resources, the Administration expects to complete the response by July 31, 2021. This will be accomplished by restricting responses to the 16 departments with \$10 million or more in **General Fund** spending across Classes 200, 300, and 400. These departments represent 92% of spending (\$929 million) in those classes. The following departments will be included in the response:

This letter is in response to questions raised by Councilmembers during the FY22 Council Budget Hearing for the Department of Commerce scheduled for May 4, 2021. At this hearing, the following questions were asked:

• Councilmember Gym: What is the 5-year investment in local Black & Brown businesses?

Commerce will focus on building wealth for Philadelphia communities, with a focus on communities of color. The racial wealth gap, which leaves white-led households in the US with approximately seven times more wealth than Black-led households, has only been exacerbated during the pandemic. This gap is not a result of income disparities alone. Commerce will ramp up strategies focused on attacking systemic barriers for BIPOC communities including capital, equity, profit sharing and property ownership. We will make investments in organizations that offer M/W/DSBE certification services to our communities. We will amplify the work of the growing CDFI network. We will help minority business incubators and accelerators expand. We will also partner with PIDC to offer a new Developers of Color Fund to grow capacity in the construction sector.

In the Mayor's proposed FY22-26 Five-Year Plan, Commerce is projected to receive the following in FY22:

- \$2,996,836 for Workforce Development including \$175,000 for entrepreneurship training.
- \$150,000 for OEO Certification
- \$300,000 for Small Business Grants
- \$452,999 for Taking Care of Business

In the City's Consolidated Plan to HUD, Commerce proposes the following uses of CDBG funds to support Black-owned small businesses in FY22:

- \$1,500,000 for Business Technical Assistance Program and BizCoach
- \$2,000,000 for Small Business Lending for business growth and/or acquisition of commercial property
- \$500,000 for InStore Forgivable Loan Program for new or expanding businesses.

In addition, the City will work with businesses to ensure that they take advantage of funding provided through the American Rescue Plan.



• Councilmember Gym: What is in our economic stimulus to PIDC?

The Department of Commerce directs Economic Stimulus Program (ESP) funds to PIDC to execute a variety of programs. Those programs include neighborhood and small business supports such as the Storefront Improvement Program and workforce development initiatives such as the Call for Ideas and Most Diverse Tech Hub startup program. Those funds also support the African American Chamber of Commerce, Asian American Chamber of Commerce, Greater Philadelphia Hispanic Chamber of Commerce, along with several other partnerships.

• Councilmember Parker: Out of the \$290M that the City spent via procurement with Black & Brown businesses, what are the industries in particular?

In FY20, \$271 Million was spent with M/W/DSBE businesses. Of the \$271 million, 50% or \$135.9 million in contract dollars was spent with the Black and Brown Community. The African American community was the largest awardee group of all M/W/DSBE contracting dollars receiving over \$100 million in contracts throughout the year. These contract dollars had the largest awards in the category of Facilities Support Services, Pharmaceutical Sales, General Construction, Legal Services, and IT Support. Of the \$32.4 million spent within the Latino community, the largest awards were in the categories of General Construction and Collection Services.

• Council President Clarke: Is there a record of how many jobs were created due to KOZ zones?

The Keystone Opportunity Zone (KOZ) program has been the City's largest incentive tool to encourage redevelopment of vacant properties for over 20 years. An analysis of the KOZ economic impact was included in the "*Philadelphia Incentives Study*" commissioned by the Commerce Department in 2019. That report (link: https://www.phila.gov/media/20190912140149/philadelphia-incentive-study.pdf) found that KOZ recipients employed more than 9,000 full-time equivalent workers annually according to data from the most recent reporting period. The report also determined that the KOZ program continues to provide positive net returns to the City as the result of wage tax and sales tax collected during the abatement period and continued enhanced economic activity following conclusion of the 10-year abatement term.

• Councilmember Gauthier: Does the reduction in funding to PIDC mean a reduction in business grant programs such as Storefront Improvement Program? What is the impact of that reduction on the number of businesses served, comparing FY20 (pre-Covid) to FY22?

The Department of Commerce directs Economic Stimulus Program (ESP) funds to PIDC to execute a variety of programs. Those programs include neighborhood and small business supports such as the Storefront Improvement Program and workforce development initiatives such as the Call for Ideas and Most Diverse Tech Hub startup program. Those funds also support the African American Chamber of Commerce, Asian American Chamber of Commerce, Greater Philadelphia Hispanic Chamber of Commerce, along with several other partnerships. Economic Stimulus Program (ESP) funding remains unchanged in FY22 but is projected to increase by \$10 million in FY23 through FY26.

The three business grant programs held at PIDC are receiving an increase of \$300,000 in General Fund dollars in FY22 and an additional increase of \$400,000 in FY23 through FY26, but that does not restore them to their pre-Covid budget levels. We will continue to manage these business and neighborhood incentives to best of our ability. However, lower funds will limit the number of businesses we can serve as well as our ability to be flexible with hard to reach corridors and business owners.

This letter is in response to questions raised by Councilmembers in advance of the FY22 Council Budget Hearings scheduled for March 5, 2021. At this hearing, the following questions were asked:

Responses are specifically addressed to inquiries posed by Councilmember Kendra Brooks

1. What does the department anticipate it would cost to have a robust mental health civilian alternative response?

For FY22, DBHIDS has requested \$7.265M as anticipated costs to expand Community Mobile Crisis Response. This includes funds for additional community mobile crisis response teams and funds to simultaneously expand the Philadelphia Crisis Line to triage incoming calls.

a. Can you estimate how many citywide units it would take to respond to every mental health crisis, either called to 911 or to the mental health line?

Currently there is one part time and one full time mobile crisis response team. Our preliminary data suggests that increasing to 4 full time (24/7) enhanced teams (including a behavioral health professional, a nurse, and a person with lived experience) would provide the necessary coverage for citywide civilian based crisis response.

- Teams will be placed in 4 regions of the city through 4 behavioral health provider organizations.
- Each of these providers will have multiple teams (one team per shift) to ensure 24/7 coverage.
- 2. There exists a dire need for more citywide units, with some district Councilmembers indicating they need 7 units in just their district alone. Would DBHIDS have capacity to scale up mobile crisis units if \$13.2M was given to the department instead of \$7.265M?

DBHIDS currently has two providers that have community mobile crisis response teams (John F. Kennedy (JFK) and the Consortium). JFK currently provides 24/7 coverage across the entire city, and the Consortium is currently working to prepare for scale up to provide 24/7 coverage. DBHIDS will be



issuing a request for proposals in the beginning of June to identify two additional providers to stand up community mobile crisis response teams.

When all four providers are on board, 24/7 coverage will continue with the city being divided into four regions:

- Each provider will cover a region.
- Each provider will have 3-4 units one covering each shift for 24/7 coverage, including weekends.

Metrics and outcomes from the implementation of the 4 Community Mobile Crisis Response Teams, in addition to the Philadelphia Crisis Line call volume, will advise us if additional expansion is needed. We would like to monitor the initial implementation and keep the Administration and Stakeholders updated on our progress and additional needs that may arise.

- 3. We have been hearing some alarming concerns about the co-responder model, including a widespread fear amongst social workers and advocates about the presence of law enforcement and their commitment to the lives of people with disabilities in the City.
 - a. What have you heard from social workers and advocates who you worked with on emergency mental health responses about the co-responder model? Do you feel you are able to address their concerns?

The universal message that DBHIDS has heard is the need to have improvements in traditional police only response to mental health and crisis related calls. We have heard an abundance of desire for enhanced community mobile crisis team response. To ensure we can respond to every call with the appropriate resources, Philadelphia's approach is to develop a continuum of response options within which the level of response will match the needs and circumstances of each 911 call while always factoring in the needs of the person in crisis, public safety, and staff safety. Identification of the appropriate response depends on the information gleaned from each call, which guides choice of response to match the needs of each call, whether that response be behavioral health only, police and behavioral health teams (co-response), CIT- trained police, or police only.

Philadelphia's co-responder model and community mobile crisis response team models are complementary and should both be viewed as critical interventions in the continuum of responses to the full range of 911 calls involving behavioral health crises.

- Co-responder teams are needed to respond to situations that require a police response (i.e., potentially violent situations, crime and/or victim involved, etc.) in addition to a behavioral health response.
- For co-responder teams, **CIT officers can resolve potentially violent situations**, while behavioral health professionals can provide consultation to law enforcement and care to individuals in crisis.
- They aim to deliver a safe, trauma-informed intervention to behavioral health crises in the community, divert crisis calls away from the justice system, and prioritize supporting individuals with behavioral health challenges in the community.



- Co-responder teams reduce arrests, reduce unnecessary emergency department visits and psychiatric hospitalizations, increase safety, and provide linkage to appropriate care and supports in the community.
- b. We have heard from advocates that they have been asked to participate in Crisis Intervention Training (CIT), but many have declined.
 - How many organizations have been invited to participate in CIT training? How many have accepted the invitation, and how many have declined?

To attend the training as recipients, we have historically included other law enforcement partners including SEPTA, UPenn, Temple, Federal Reserve. The availability of those seats is determined based on capacity and rostering by the Philadelphia Police Department.

To attend the training to help deliver the training: Since 2007 we have drawn from a variety of partners who have helped with parts of the curriculum. Currently, those include university partners such as Drexel's ASERT program on autism; NAMI; and the Veterans Administration.

DBHIDS has no record of organizations being offered the opportunity to participate in CIT training and declining.

- How many PPD officers have signed up for CIT?

 Since inception in 2007, CIT has been provided to over 3,000 PPD officers and 271 additional officers from other locales.
- How many PPD officers have signed up to participate in the co-responder model?

4 officers were chosen to participate in the pilot program. The identification of PPD officers for co-response was handled by PPD. DBHIDS recommends follow up with PPD for additional information regarding selection.

- 3. Could you share more about CIT training and whether it would override some of the training that officers learn at the academy?
 - a. Are officers trained to assess threat levels differently when responding to a crisis intervention call than when otherwise responding to a call? What is different about this response?



These questions have been forwarded to the Philadelphia Police Department and will be circulated to Council.

- 4. Does CIT training address the use of lethal force in mental health circumstances?
 - a. Are CIT trained officers instructed to only use tasers during a mental health response?
 - b. How does training account for instances when the officer says they forgot or mistakes their firearm for a taser, as was recently the case in Minnesota with Daunte Wright?
 - c. Is an officer trained to override firearms training taught at the police academy, which encourages officers to fire their weapons and target the individual's torso to incapacitate?

These questions have been forwarded to the Philadelphia Police Department and will be circulated to Council.

This letter is in response to questions raised by Councilmembers during the FY22 Council Budget Hearing for the Department of Public Health scheduled for May 5, 2021. At this hearing, the following questions were asked:

1. **Councilmember Green:** Of the \$750M that goes to nonprofit contracts, what percent go to minority-controlled organizations?

PDPH does not have \$750M in contracts to nonprofit organizations. The entire budget of the health department for FY22 is \$728M, but \$322M of this is the Hospital Assessment, funding which the department receives from hospitals and transfers in large part to the Commonwealth. Of the General Fund and Grants, approximately \$266M is proposed to be spent in contractual purchases of services, which includes contracts to both nonprofit and for-profit organizations.

Nonprofits organizations are not classified as "minority-controlled" or not. However, information is available on the minority makeup of the workforce, executives, and boards of these organizations. This information is provided for the largest five nonprofit vendors on page 22 of the budget testimony. In summary, of these five vendors, four have workforces that are 65% minority or greater and three have boards of that are greater than 50% minority; the percent of executives that are minority ranges from 17% to 51%. We have numerous contracts with smaller non-profit organizations; a summary of the race/ethnic makeup of the other nonprofit vendors will take longer to produce. Please let us know if you are interested in our preparing such a report.

2. **Councilmember Domb:** What is the total number of Pfizer doses in freezers that have not been distributed to providers? How many are in the freezers of providers?

This letter is in response to questions raised by Councilmembers during the FY22 Council Budget Hearing for the Department of Revenue on March 4, 2021. At this hearing, the following questions were asked:

1. Councilmember Gym: What is the City doing to collect out of state business taxes from online retailers such as Amazon? What are the results of your efforts and how have out of state gross receipts tax collections improved?

The Department of Revenue is dedicated to uncovering taxes owed to the City of Philadelphia. Beyond the Department's internal enforcement tactics, the Department of Revenue contracts with external vendors to expand capacity. These vendors are contracted to uncover businesses located outside of Philadelphia but doing business here and not paying taxes. In FY21 the Department of Revenue expanded capacity, adding a second vendor to this work. Additionally, in April 2021, the Department re-issued the RFP for Discovery and Delinquent Collections to continue this collections strategy into FY22.

The most recent data is in Appendix A. We have included a breakdown for Philadelphia assessments, and assessments outside of Philadelphia, as we believe this shows a more complete picture of our discovery activities. Note, our second vendor did not come on-board until August 2020, and continue to ramp up their operations throughout FY21.

Since FY18 through May 7, 2021, the Department of Revenue made nearly 2,800 assessments valued at over \$12.5 million. About 24% were against companies located outside of Pennsylvania, valued at \$9,904,706, or about 79% of the total assessments due. As you can see, assessments against firms located outside Pennsylvania are far larger than those against Pennsylvania firms.

2. Councilmember Brooks: You noted that the decrease in BIRT revenue will increase and will balloon to \$65M. How much of BIRT tax revenue loss will go to the 10 wealthiest corporations and how much will they save in FY22 and through FY26?

This analysis has not been completed; the Administration is evaluating how this can be done and will provide updates when more information is available.



3. Councilmember Parker: Report on real estate tax collections. (Parker is asking for DOR's one-pager/report of delinquencies and collection rates)

4. Councilmember Brooks: One of the goals is to pursue tax delinquency with tax abated properties. What is the number of tax delinquent properties with a tax abatement and the amount owed?

As of December 31, 2020, about 1,200 property owners with a tax abatement were delinquent on their Real Estate Tax, business taxes, Water charges, and/or Commercial Trash Fees and owed approximately \$9.6 million in total debt to the City of Philadelphia. The total number of property owners with an abatement and delinquency represented a little over 7% of all owners with a tax abatement.

The table below breaks down the number of abated properties by type of delinquency.

• Councilmember Henon: Provide the number of businesses that went into payment agreements from tax year 2019 to 2020 (businesses that have been "saved")

While it is difficult to calculate the number of businesses "saved" because of City intervention, throughout the pandemic many City departments have coordinated efforts to support business recovery in neighborhoods across Philadelphia. For example, alongside Revenue's initiatives, the Department of Commerce directly administered, placed or pledged \$26.8 million to support the recovery of 3,177 businesses- 63% of which were woman- or minority-owned.

In July 2021, the Department of Revenue announced new Recovery Payment Agreements for any businesstaxes owed after March 2021. These agreements offered businesses up to 12 months to pay without

interest or penalty. Revenue updated and softened its letters to notify businesses about these new payment agreements.

Additionally, throughout the pandemic, Revenue did not place accounts already in a payment agreement into a "default" status in Revenue's system for failure to make a payment on an existing agreement. This action protected property owners and businesses from enforcement actions. Since April 2020, 179 business tax agreements would have defaulted on a payment agreement if the Department had not taken this action.

The table below shows the number of accounts that entered into a payment agreement from March 1, 2020 to April 1, 2021. Of the agreements listed below 24 were eligible for Recovery Payment Agreements; seven agreements are already completed and 17 are active.
