Applicant: PHDC in partnership with Philadelphia Energy Authority



Scale of Problem in Philadelphia is Significant:

We need approximately \$7.4 billion to meet the basic needs of existing low-income households.

- 116,645 household at 0%-30% of AMI, report one or more major housing problem
- + 58,055 households at 30% -50% of AMI report one or more housing problems
- + 261,646 HH or 16.7% of low-income households report have a family member with a physical disability

DPD Consolidated Plan 2022-2026

Housing Action Plan set aggressive goals for production and preservation to serve 100,000 over ten years.

PHDC

PHDC is Philadelphia's full-service community development non-profit corporation and works closely with the Department of Planning and Development (DPD) to implement housing investment programs.

PHDC budget for FY23 is \$74M for

Basic System Repair Program (BSRP) & Adaptive Modification Program (AMP)

- BSRP & AMP serve households at or below 60% of AMI (for a family of 4 equates to \$63,250)
- Annually BSRP and AMP provide approx. 8,500 improvements to 3,500 homes
- PHDC's average BSRP/AMP investment is \$17,000 per home
- BSRP resolves electrical, plumbing, heating, structural, and roofing problems
- AMP provides modifications to allow residents with physical disabilities easier access in/within their homes
- PHDC layers AMP & BSRP to support
- PHDC is expanding partnerships to leverage federal funding to expand improvement- to address health and energy improvements in the home.

PHDC also provides approximately 1,500 emergency heater repairs or replacements each year through the Heater Hotline Program and the LIHEAP CRISIS Heating Program

PHDC: Home Improvement Program Contractors

- Annually, 59% are awarded to MBE/WBE Firms (certified & non-certified firms)
- 100% are awarded to small and mid-size firms
- Partnership with JEVS to hold annual hiring fair 100+ contractors/developers to offer job opportunities in trades
- PHDC builds the capacity of firms each year to grow number of jobs and employees

PHDC funds

\$5 million

- Grant Administration
- BSRP and AMP Program Enhancement
- Case Management System:
 - Streamline application processes
 - Expand info sharing between organizations that are working to improve housing stock for low-income resident
 - Capture data on households serve and develop metrics on performance

Housing Helper Tool- will be expanded as a gateway resource for consolidating programs for residents to view programs https://dpdhousingbenefits.phdcphila.org/#/

Rental Improvement Fund \$5 million

WHR will fund a 15-year forgivable loan of up to \$50k.

Eligibility

- Landlord owns no more than 5 properties and 15 units
- Current rent is affordable to households under 60% AMI
- Unit(s) to be repaired must currently be occupied by a tenant
- Property must be able to meet building code after repairs are completed; a rental license must be obtained for the property immediately following the repair work if one hasn't already been granted

For the loan to be forgiven, annual rent increases can't exceed 3%.

PEA Built to Last

\$7.7 million

Built to Last coordinates, layers and supplements existing home repair programs to preserve existing affordable housing, ensuring they are affordable, healthy and safe for the long term.

Workforce Development \$1.3 Million

- Green Retrofit Immersive Training (GRIT) program
 - Managed by PEA with ECA
 - Training 2 cohorts averaging 20 students (18 weeks)
- Heat Pump Skills Training program
 - Managed by ECA
 - Serves up to 15 students per cohort (5 weeks)
- Carpentry Fellowship
 - Managed by Habitat for Humanity Philadelphia
 - Supports 3 trainees for 1 year -On-the-Job Training + Benefits



Program Promotion

Built to Last - existing waitlist for FY23/24 is 110 income-qualified homes.

BSRP/AMP no current waitlist.
